



## Fall 2020 Scott County Dual Credit Student Scholarship Application

The Scott County Dual Credit Student Scholarship fund provides scholarships to cover the cost of tuition for high school and home school 11<sup>th</sup> and 12<sup>th</sup> grade students who reside in Scott County, exhibit financial need, and take BCTC dual credit classes at the Georgetown-Scott County Campus of BCTC or a Scott County high school. This scholarship will be applied after a student has exhausted Kentucky Dual Credit Scholarships (KHEAA) for two dual credit courses and/or available Work Ready Kentucky Dual Credit Scholarships.

**Awarding Criteria:** Successful scholarship applicants must be high school or home school 11<sup>th</sup> or 12<sup>th</sup> grade students who meet the requirements for enrollment into the dual credit class, are residents of Scott County, Kentucky, and are eligible for the Free and Reduced School Lunch program. Applicants must have completed their application to BCTC online at [bluegrass.kctcs.edu/admissions/index.aspx](http://bluegrass.kctcs.edu/admissions/index.aspx) and must meet course-specific, ACT or placement test score requirements, and course prerequisites.

**Instructions:** Please complete all sections and sign the application. The submission deadline for scholarship applications for Fall 2020 is **July 10, 2020**. Consideration will be given to applications submitted after the deadline by new students that have transferred into Scott County Schools.
