Spring Final Exam Schedule

No final exam may be given before the period published in the Academic Calendar.

Courses that begin at times other than the times listed above will be considered as meeting at the closest preceding meeting time as listed above.

If a final examination is to be given, it will be administered during the examination period as established by the official academic calendar for BCTC. In determining the date of the final examination, “classes that begin” refers to the initial class meeting of the normal instructional week (Monday through Friday). Final examinations may be given at times other than the regularly scheduled time in the following instances:

Faculty:

In the case of conflicts or undue hardship for an individual instructor, a final examination may be rescheduled at another time during the final examination period upon the recommendation of the Assistant Dean of the division and with the concurrence of the Office of Academics and the Registrar.

The location of the final exam for Hybrid classes that meet T (T_{hb}) or W (W_{hb}) at 9:30, 12:30, 3:30, or 6:30, and M (M_{hb}) or R (R_{hb}) at 8:00, 11:00, 2:00, 5:00, or 8:00pm will be determined and announced by the instructor of the course.

Students:

Students in Hybrid courses that meet T (T_{hb}) or W (W_{hb}) at 9:30, 12:30, 3:30, or 6:30, and M (M_{hb}) or R (R_{hb}) at 8:00, 11:00, 2:00, 5:00, or 8:00 pm will need to consult their instructor for the location of the final exam. In the case of a final examination conflict for an individual student, a final examination may be rescheduled by mutual agreement with the instructor during the final examination period.

Any student with more than two final examinations scheduled on any one date shall be entitled to have the examination for the class with the highest catalog number rescheduled at another time during the final examination period. In case this highest number is shared by more than one course, the one whose departmental prefix is first alphabetically will be rescheduled. The option to reschedule must be exercised in writing to the appropriate instructor no later than one week prior to the last class meeting.

If an examination schedule conflict is created by faculty rescheduling of an examination, the student shall be entitled to take the rescheduled examination at another time during the examination period by mutual agreement with the instructor. In the case of undue hardship for an individual student, a final examination may be rescheduled by the instructor.
